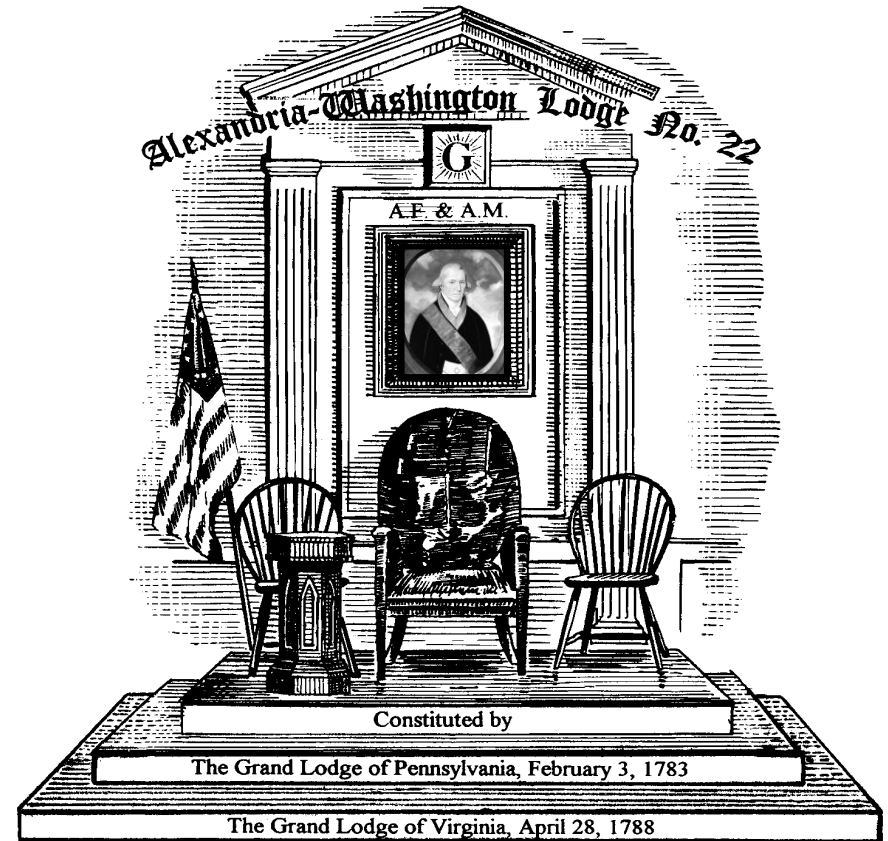
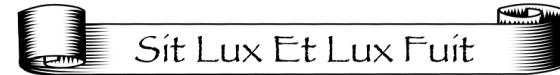

This summer, Bro. Tim Winkle asked to step back from his Archivist duties. The Lodge is very thankful for his years of service and care for our collection. The Archives Committee immediately began a search for a new Archivist. Bro. Winkle, being a museum professional, set our expectations high. The Lodge is fortunate to have enlisted Steve Stuart.

Originally from New Martinsville, West Virginia, Steve graduated from the University of Delaware with a degree in Art History. His graduate studies have been in American Art at Delaware and in Decorative Arts at the world-renowned Winterthur Museum, Garden & Library in Winterthur, Delaware.

Steve's resume includes the Virginia Museum of Fine Arts; Valentine Richmond History Center; Hillwood Estate, Museum, and Gardens; and George Washington's Mount Vernon Estate and Gardens. In the 20+ years he has worked in and around museums, Steve has assisted in exhibit design and interpretation, worked as a conservation technician, and served as a Collections manager. He has hands-on experience in the proper care, handling, cataloging, and preservation of irreplaceable artifacts.

In addition to serving as Lodge Archivist, Steve works with the Henderson Group Unlimited and assists with Official State Visits at the President's Guest House, Blair House (U.S. Department of State). He volunteers with the White House Visitor's Office and Visitor's Center and has previously been a member of the Presidential Correspondence Volunteer corps for the President of the United States. Currently, Steve serves as a member at large of the Historic Alexandria Resources Commission. He resides with his fiancé in Alexandria.

Steve shares our appreciation and admiration for Illustrious Brother George Washington. His professional experience with Early Americana and at Mount Vernon has imbued him with the understanding of Washington's magnitude in our country. We are fortunate to have him in our service.

## PROPOSED CHANGES TO THE BY-LAWS AND STANDING RESOLUTIONS (TO BE DISCUSSED AND VOTED ON AT THE NOVEMBER STATED COMMUNICATION)

### Standing Resolutions No 1, paragraph 2

The Committee on Archives shall be a continuing committee composed of ~~five~~ **eight** members consisting of the Lodge's representative to the George Washington Masonic National Memorial Association, **the three Stationed Officers**, and four other members whom shall be nominated by the Master and elected by the Lodge. When the Committee on Archives is reinstated in November, 2017 the Master shall nominate four members who shall serve for the remainder of 2017 and then beginning in January, 2018 serve terms of one, two, three, and four years. In each succeeding year, the Master shall nominate a replacement for the member whose term is expiring. That member and all who follow shall each serve four year terms. In the event a vacancy occurs at any time among the four elected members, the Master shall order an election to be held to fill such vacancy. Each year the members of the committee shall elect a chairman to serve for that term. The Stationed Officers of the Lodge are expected to attend and encouraged to participate in all meetings of the committee.

REASON: least amount of tweaks to clarify that the 3 stationed officers are voting members.

### By-Laws:

Article 1-continued (to add what is shown in bold below and a tweak to Charter Night to ensure it is always in April now that we only have one stated communication per month)

The Lodge shall observe the birthday of Illustrious Brother George Washington with a Stated Communication to be held on February 22nd of each year at a time of the Master's choosing. If February 22nd falls on a Sunday, the meeting shall be held on the following Monday.

(change)

The Stated Communication ~~nearest~~ **in** April ~~28th~~, shall commemorate the anniversary of the date of the Lodge's original Virginia Charter, April 28, 1788.

(add)

**The Lodge shall observe the November Stated Communication on the first Thursday of November when it coincides with the date of the Grand Annual Communication.**

REASON: least amount of tweaks to ensure our 'Charter Night' is held in April not May since we have one stated communication per month not two. The bold print is to add that sentence to the bylaws Article 1 (continued). This avoids having to request the necessary dispensation required to move the meeting date.
